

SUMMARY ANNUAL REPORT

Plumbers and Pipefitters Local Union No. 396 Health and Welfare Fund

This is a summary of the annual report for Plumbers and Pipefitters Local Union No. 396 Health and Welfare Fund, (EIN: #34-6545105 PN: 501) for the year ended March 31, 2022. The annual report has been filed with the Internal Revenue Service, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has insurance contracts with Medical Mutual of Ohio and Humana Insurance Company to pay certain medical and prescription claims incurred under the plan. The plan has an insurance contract with the Union Labor Life Insurance Company to provide risk coverage against high-value claims incurred under the plan. The total premiums paid during the year were \$767,829.

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust Fund. Plan expenses were \$5,449,298, which included \$454,688 in administrative expenses and \$4,994,610 in benefits paid to participants and beneficiaries. A total of 551 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$10,890,464 as of March 31, 2022, compared to \$8,028,353 as of March 31, 2021. During the plan year, the plan experienced an increase in its net assets of \$2,862,111. This increase includes unrealized appreciation/ (depreciation) in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost assets acquired during the year. The plan had total income of \$8,311,409 including employer contributions of \$7,078,214, participant contributions of \$682,553, income from investments of \$280,609, other income of \$668,883, and losses from investments of (\$398,850).

You have the right to receive a copy of the full annual report, or any part thereof, upon request. Included in that report is an accountant's report, schedule of assets held for investment purposes, and actuarial information regarding the funding of the plan.

The charge to cover copying costs given above does not include a charge for copying these portions of the report, which are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, 3660 Stutz Drive, Suite 101, Canfield, Ohio 44406, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor on payment of copying costs.
